

Privacy Policy

Thanks for using our products and services (“Services”). The Services are provided by One Shot Technologies Ltd located at Dosandaero 145 Inwoo Bldg 5th Floor 516, Seoul, South Korea. By using our Services, you are agreeing to these terms. Please read them carefully.
